#### XI. ANY OTHER OBSERVATION:

- 1. Infrastructure of the Institution is very good. Management has been supportive towards the over-all development of the Institution.
- 2. The Library is appreciable and well equipped but it may be supplemented with some more copies of prescribed and reference books for BB.A. LL.B.
- 3. Committee had good interaction with the students. The students were very interactive and enthusiastic. However they had grievances about alleged erratic valuation by KSLU.

On going through the interaction with the students of different colleges visited by the Committee and their common grievances regarding valuation and in view of the RTI wave in the country, the Committee strongly opines that a) the custodian for valuation must mandatory be a law person and b) valuation be done strictly by the teachers teaching the respective subjects.

4. Committee also interacted with the faculty. The faculty was of the opinion that the syllabus be revamped.
